It is my pleasure and honor to present to you the enclosed Quasquicentennial Corporation Certificate recognizing The Kenney as having been incorporated since June 21, 1901.

On that day in 1901, members of your organization appeared before the Secretary of State Grant Hinkle to formally incorporate. Although your organization may have existed long before, it was in 1901 that they sought the protections that come with incorporating.

While I do not know your group's circumstances, incorporations were delivered by boat, train or horseback at that time. Because the roads outside Olympia were minimal, incorporating was quite an adventure. Of the nearly 3,000 incorporations filed in 1901, yours is one of 22 still in operation.
